## **ORDER**

On September 13, 2021, the Hearing Panel Subcommittee of the Lawyer Disciplinary Board, by its Chair Stephen M. Mathias, in accordance with Rule 3.10 of the Rules of Lawyer Disciplinary Procedure, filed its written recommended disposition in this matter, recommending that:

- (1) Respondent be issued a reprimand;
- (2) Respondent be required to take an additional six (6) hours of Continuing Legal Education in the area of legal ethics and law office management above that which is already required with the current reporting period at the time of issuance of discipline;
- (3) Respondent be placed on one (1) year of supervised practice by an active attorney in his geographic area in good standing with the West Virginia State Bar; and
- (4) Respondent be required to pay the costs of these proceedings pursuant to Rule 3.15 of the Rules of Lawyer Disciplinary Procedure.

On February 16, 2022, the Office of Lawyer Disciplinary Counsel, by Andrea J. Hinerman, Senior Lawyer Disciplinary Counsel, filed its consent to the recommendation. The respondent did not file a consent or an objection to the recommendation.

Upon consideration, the Court is of the opinion to and does concur with and approve the recommended disposition of the Hearing Panel Subcommittee of the Lawyer Disciplinary Board. It is ORDERED that:

- (1) The respondent, Timothy P. Rosinsky, is reprimanded;
- (2) Respondent is required to take an additional six (6) hours of continuing legal education in the area of legal ethics and law office management over and above the hours required during the current reporting period;
- (3) Respondent is placed on one (1) year of supervised practice, with his practice to be supervised by an active attorney in his geographic area in good standing with the West Virginia State Bar; and
- (4) Respondent is required to pay the costs of this disciplinary proceeding in accordance with Rule 3.15 of the Rules of Lawyer Disciplinary Procedure.

Service of a copy of this order upon the respondent, Timothy P. Rosinsky, the Office of Lawyer Disciplinary Counsel, and the West Virginia State Bar, constitutes sufficient notice of the contents.
